On February 1, 1999, the last Black History Month of the 20th Century,

Black Voices publish the result of a national survey that was concerned with
the following; who were the individual that the nation's 38 million strong

African American Community considered the 100 most Influential Black

Americans of the 20th Century. And what contribution did each individual
