Good morning, J.J.

In all fairness, I am still "digesting" last evenings conversation with Dr. Fletcher. 41 years ago, and during these years since that time; Any time the African American Community asked for my help; My services were not requested to be "paid for." Any time, I did as requested; I did it, AS; IT WAS THE "RIGHT THING TO DO."

I sat, and listened last evening, to, what in my own personal opinion (as a Constitutionalist), was, and IS the CATALYST to LOSING OUR CONSTITUTIONAL RIGHTS TO CONSTITUTIONAL REPRESENTATION. In other words, J.J.; AMERICANS MUST PAY TO HAVE ACCESS TO THE "LEGISLATURE and OTHER INDIVIDUALS ALLEGING "POWER BROKERS"... This is unacceptable to me. I, in all fairness, do not BELIEVE "THE CONSTITUTION, OUR LIBERTIES, OUR FREEDOMS, OUR RIGHTS "CAN BE BOUGHT, OR ARE FOR SALE." AFRICAN AMERICANS, should be the MOST AWARE of this problem, not allowing themselves to be a "part of the problem, but a resolution to the problem."

I sat, and listened to you last evening, and was very impressed. Admittedly, "impressed" is putting it mildly. All of us were very impressed with your accomplishments, and knowledge. Your conversation was, and is very refreshing, to very tired, elderly ears. Your conversation did not fall on "closed minds, or closed ears."

In regards to the "information" on the "minerals" etc.. I have known about this, for many years, and object to the "infra-structure" dismantling in those nations.

You made a statement to me last evening, regarding the POWER of the UNITY OF AFRICAN AMERICANS. This "unity" is exactly what is needed to "cut the Gordian Knot" in the banking circle; of the "Billionaire Boys Club" in the Banking Industries.

During my husband's 1940 "U.S. Service"... He was listed as BLACK, as he was predominantly SIOUX & GERMAN. Having SIOUX lineage, he was listed as BLACK, and put into the ALL BLACK UNITS based on THE "ONE" DROP theory.

Discrimination, is not a "new" thing.

Let us now, deal with DISCRIMINATORY PRACTICES. Public Law 89-497, 271. 81 Stat. 1 U.S.C. Sec. 113 (1966) in regards to BILLS OF LADING; Prohibits DISCRIMINATION. However, later publications have deleted those "discriminatory practices provisions."

The U.S. Constitution Art. 1. Clause 10; Prohibits Congress from interfering-meddling with CONTRACTS.

RESTRAINT OF TRADE is "prohibited" by Federal and State Laws.
