INSTRUCTIONS

Deposit the item at your bank with instructions that it is a "Pre-Paid Treasury Direct Item/Treasury Voucher/Warrant" which is processed through your bank's "Collections Dept". The "Collections Dept" will fill out an "OUTGOING COLLECTION" form directed to the collections department with instructions for them to perform a "Paper Conversion/EFT ONLY (paper item to electronic transfer) to directly credit your account. This instrument functions as a Treasury Warrant (see Black's Law Dictionary, 7th ED, page 1580)

It is not unusual for your bank to put a hold on your account for the item for 15-days that will be released when your account is credited. If it is returned to your bank, stamped "Closed Account" or "Could not Locate Account" your bank has processed it as normal check via ACH (Automated Clearing House) to the account displayed on the item for collection instead of THROUGH the account via paper conversion EFT ONLY to the Treasury Dept for credit. Send it back and tell them it is a Treasury Direct Exchanged Item EFT Only.

The closed account displayed on the item is a private "Payable through" account UCC registered with Secretary of State and the Treasury Department, closed, but open on the private side for "Adjustment and Set-Off" as stated in Black's Law Dictionary. If your institution isn't willing to accept this "Treasury Direct Item"/"Private Commercial Paper" please contact the "original the writer" immediately. Your bank is a private corporate minister officer, not a judicial officer and by law does not have power of discretion. According to the UCC they MUST accept the item and process it in a timely manner. Refusal to process the item is in violation of multiple UCC & banking laws and regulations, and may be reported to the Secret Service and a notarial protest may be initiated with show cause.
