Letter to the Editor:

On WDAY AM Radio's Viewpoint FIB Radio Talk Show on Friday 28 July 1995 Rudy Boschwitz said that the American Israel Public Affairs Committee was not a political action committee. (AIPAC) Is Rudy un-mis-disinformed or is he a blatant pervaricator? It has to be one or the other. AIPAC is the coalition of 200 or more like-minded PACS who collectively make up the largest lobbying political campaign contributor in the world! In 1988 the coalition consisted of 78 pro-Israel PACS. Their number has multiplied exponentially since 1988..and they today own the congress of the United States Washington Corporation!! They contribute not along party lines, but to the most loyal Pro-Israel Congressional Officers of that Washington Corporation whether they be Demoblican or Republicrat. It makes not one whit of difference, the party affiliation. Nor is there one whit of difference between the Republicrat and Demoblican politician. They all sleep in the same bed. Where are the statesmen Sons of the Republic? Did they all die 200 years ago?

Although three quarters of Pro-Israel PAC contributions in 1984 went to Democrats, Rep. Rudy Boschwitz of Minnesota, chairman of the Near Eastern Affairs Subcommittee of the Senate Foreign Relations Committee, received \$125,775 toward his successful 1984 re-election campaign. It was more than half of the Pro-Israel PAC money spent on Republican Senatorial Campaigns nationwide in that election cycle. Other Senatorial candidates in 1984 who received \$4500 or more from the Pro-Israel PACS included Albert Gore (D-TN), Norman D'Amours (D-NH), William Winter (D-MS), Howell Heflin (D-AL), and Max Baucus (D-MT).

An article in the Detroit Jewish News explained that Republican Rudy Boschwitz, "who has a perfect voting record on Israel," probably will not face a strong Democratic candidate in Minnesota. The message here, which turned out to be erroneous, was that there was no need to send money unless the newspaper reported later that Boschwitz was in trouble. Although he was the fourth largest recipient of Pro-Israel PAC donations in 1990, Minnesota Republican Sen Rudy Boschwitz was defeated by his Democratic challenger Paul Wellstone, a former State campaign manager for Jesse Jackson and an outspoken supporter of self-determination. After his win Wellstone continued to express his opinion that, "eventually there will be land for peace and the Palestinian people will have some sort of a homeland."

Boschwitz received \$144,150 from Pro-Israel PACS in the 1990 cycle, as compared to Mr. Wellstone's \$2000. One reason these PACS were unable to turn the tide was that they at first did not realize that Wellstone would turn out to be such a strong candidate. Another factor was that Boschwitz, when he realized that he was losing, signed an ill-advised fund-raising letter, aimed at Jewish contributors nationwide, which seemed to say that although Wellstone was Jewish, Boschwitz was a **better** Jew!. The letter pointed out that Wellstone's wife was not Jewish and their children did not go to Jewish schools. Whatever the effect on potential out-of-state Jewish contributors, the letter had an extremely negative effect on Minnesota voters when they learned about it through the mass media.

Meanwhile, Boschwitz, who had done many favors for Israel as ranking member of the Near East and South Asian Affairs Subcommittee of the Senate Foreign Relations Committee, found there are other rewards for faithful supporters of Israel. He was named President of the Jewiash Institute for National Security Affairs (JINSA), which lobbies Congress on behalf of Israel's foreign exchange-earning arms industry for the release of sensitive US technology and High-tech weaponry to Israel.

At the direction of Martin Indyk, newly naturalized American citizen appointed by Pres. Clinton to his post, the Mossad operative who controls US State Department Policy toward all Mideast Countries, the embargo on Iranian oil has brought about a life-saving coalition of historic enemies--Iran/Iraq--to enable their mutual defense against their most formidable enemy, the American/Israel Compact!!

President Clinton has brought about changes desired by Boschwitz, Dole, Gingrich, Metzenbaum, Schumer, Reagan, Bush, Kissinger, Gorbachev, the UN, and New World Order advocates world wide, including world bankers and World Council of Churches and World Health Organization and New Age Environmentalists!!
