1. **Birth:** Of the proof submitted, only the Affidavit of LeRoy Palmer is relevant to prove birth, date of birth, and place of birth.
2. **Parentage:** Of the proof submitted, the Affidavit of LeRoy Palmer, the marriage certificate of LeRoy Palmer and Phyllis Edna Fletcher, and the birth and death information of Phyllis (Fletcher) Palmer are relevant. However, the marriage and birth certificates are not certified copies.

For the Court to grant your request for a delayed birth certificate, please file additional Supplementary Proof. Such proof could take the form of affidavits from persons who assisted or were present at the birth; affidavits of siblings regarding their relationship to you; certified copies of any records showing a parent-child relationship between LeRoy and Phyllis Palmer and Doc Palmer (i.e., medical bills, baptismal records, elementary school records, etc); and/or records of state agencies (welfare, food stamps, etc.) or court documents that substantiate the birth or show the parent-child relationship.
