“The Court expects that 25 years from now, the use of racial preferences will no longer be necessary to further the interest approved today.”

Justice Sandra O’Connor, writing for the majority of Supreme Court Justices that joined in a 5 to 4 decision to allow race based Affirmative Action Admission Policy to continue as national public policy for another 25 years or less.
